Summary:	<p>USCCB is a church sponsored organization chartered to provide Catholic bishops with guidance and church policy in current events. They often circulate documents internally and needed a system to keep track of the status of contributor's comments on policy position papers.</p> <p>The system allows users to create consultations, upload documents to support the consultation, invite participants to enter comments and collates the responses. It automatically sends emails to the originator whenever someone participates in a consultation. A suite of administration tools allow the administrators to modify functionality.</p> <p>Code Gurus was the sole developer for the application and database. Dragonfly Communications performed graphical design.</p>

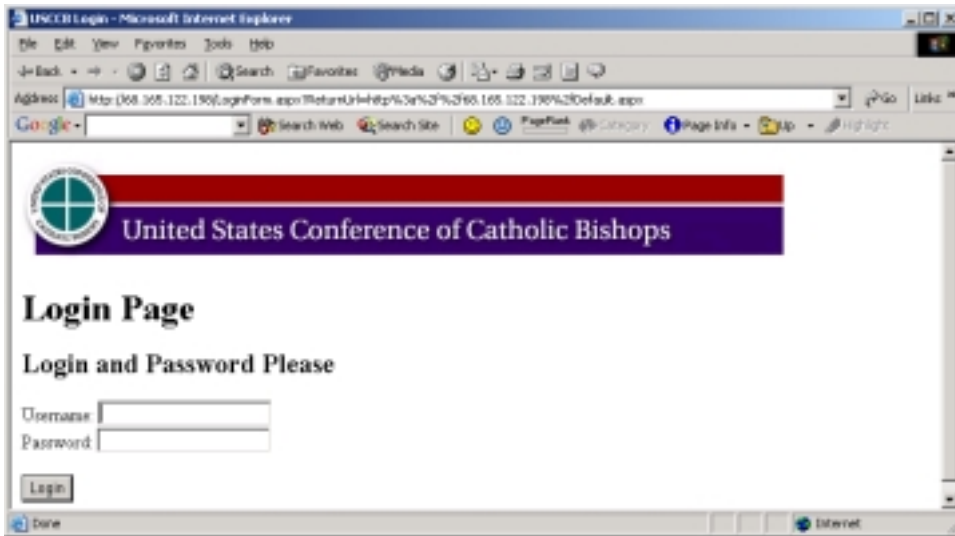


Figure 1 - Log In Page

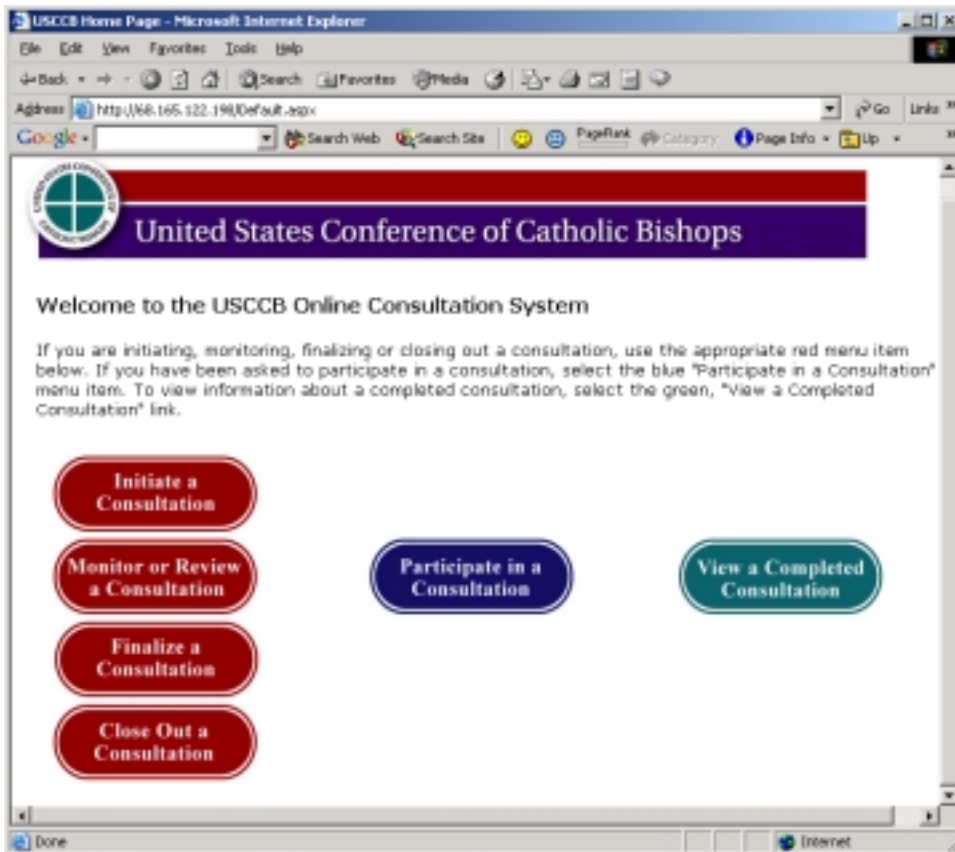


Figure 2 - Main Page

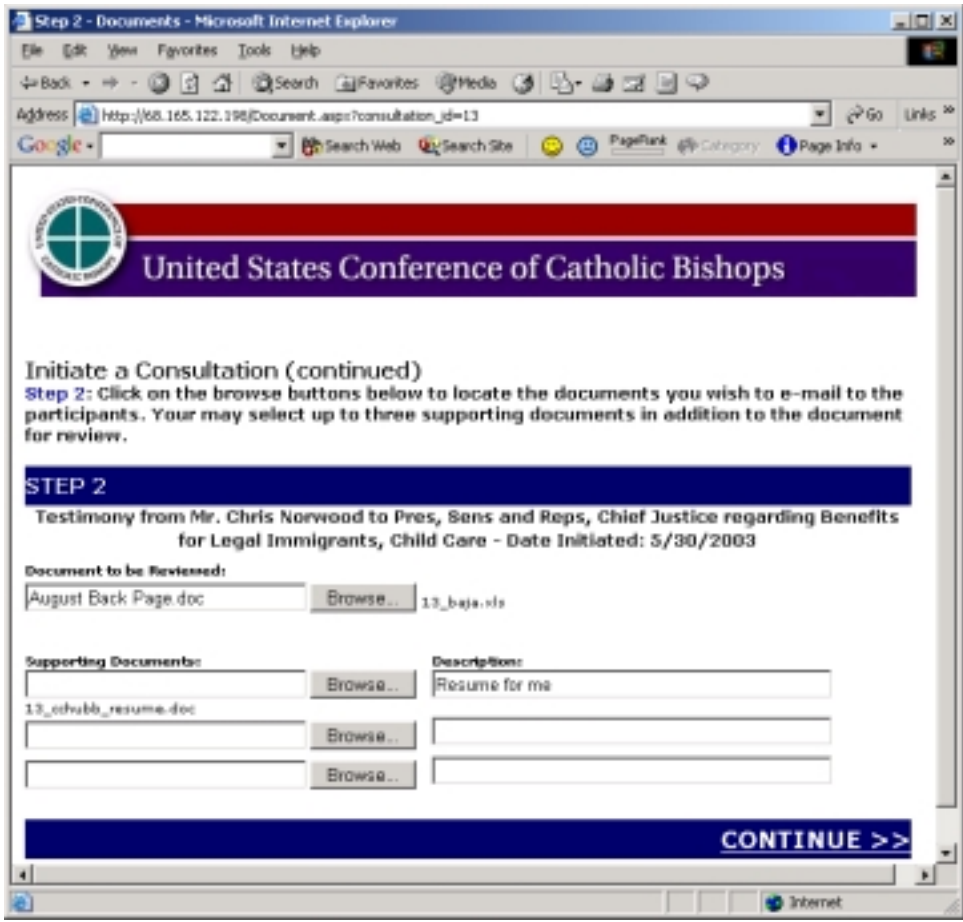


Figure 5 - Upload Documents

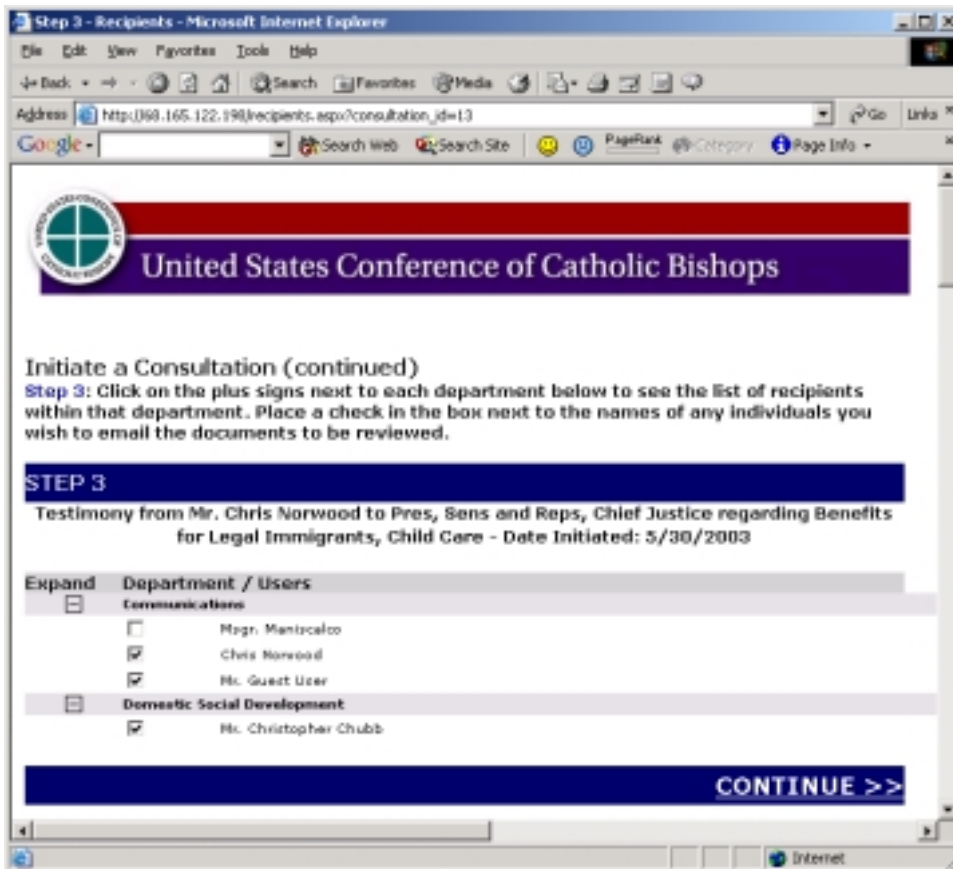


Figure 6 - Invite Participants

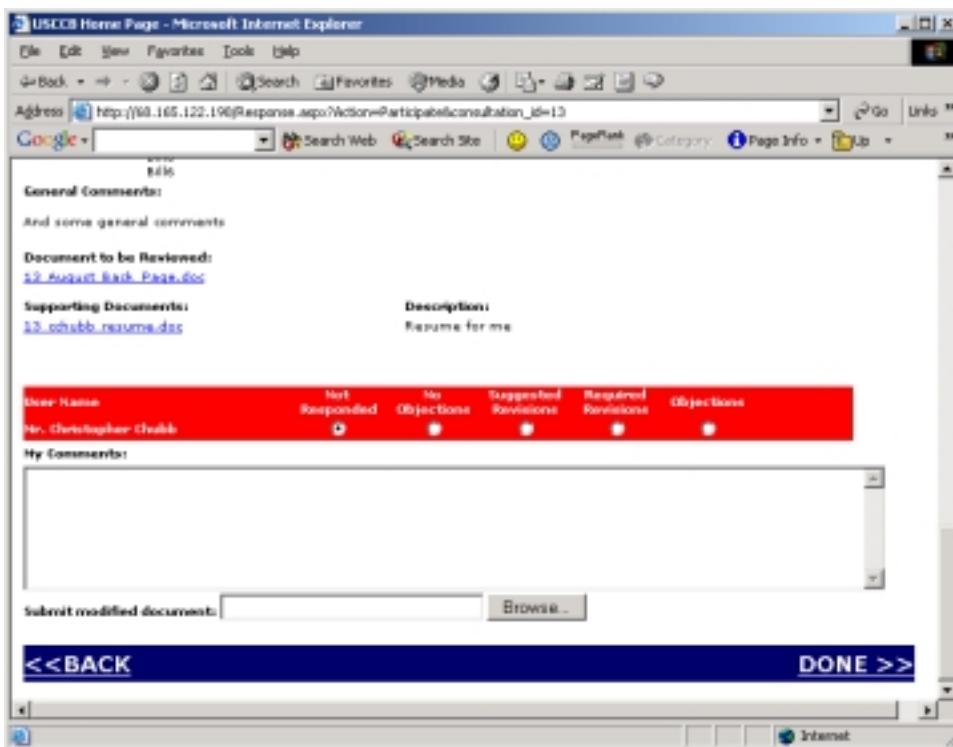


Figure 7 - Participate in a Consultation

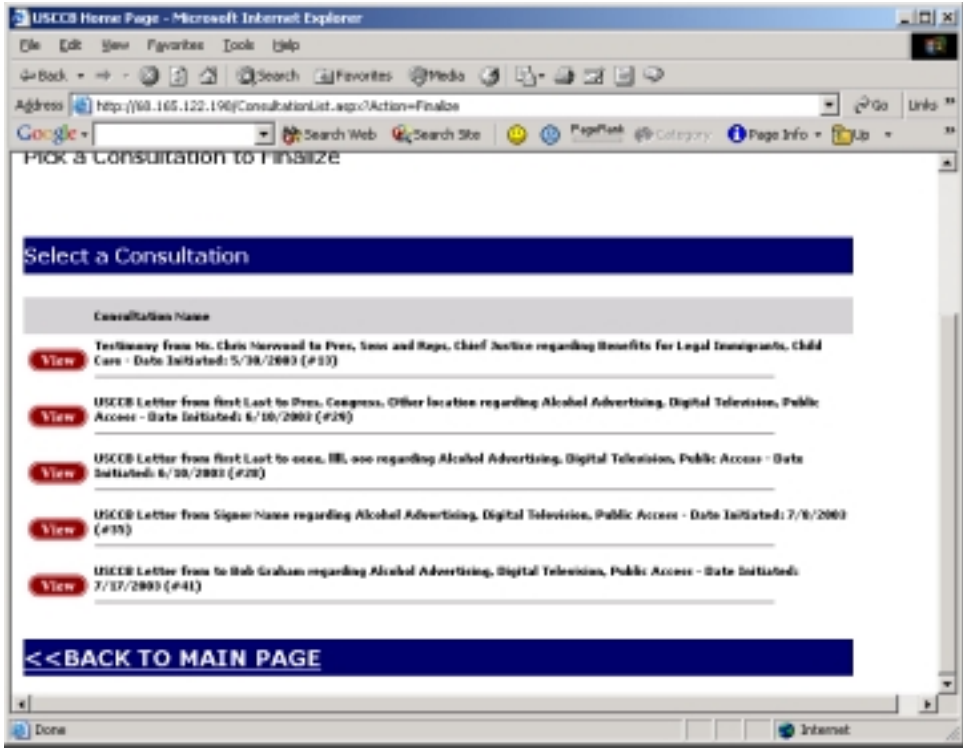


Figure 8 - List of Consultations
